Agenda No. 1 (Welcome address by Sri SaroshBodhanwalla)

Sri Sarosh Bodhanwalla, Vice Chairman HRAO welcomed all members to the 34th EC Meeting held in Balasore. He informed balasore hoteliers are overwhelmed by the gesture and this will help in improving tourism in Balasore.

Sri Bodhanwala informed that there are many popular tourist places in Balasore which needs massive infrastructure development and campaign to attract tourists across the world. They will submit a detail list of problems being faced and steps required to develop tourism infrastructure in Balasore District and requested HRAO to take up the matter with the Tourism Department.

Agenda No. 2 (Confirmation of last 33rd EC Minutes)

Sri Milind Gupta, Secretary General read out last 33rd EC Minutes before house & the house confirmed the same.

Agenda No. 3(Purchase of Water Bottle in Hotels)

The matter was discussed in detail by the members present and it was resolved that a Restaurant or a hotel cannot compel a customer to buy water bottle. He has to provide free drinking water. Cases were filed in sambalpur for selling water above MRP and the adverse verdict by the local court was tuened down by the state forum in lieu of the supreme court verdict .(Attached MRP Judgement on Water dt. 12.12.2017)

<u>Agenda No. 4</u> (Industrial Tariff on Electricity Charges)

Lifetime Chairman said that it was discussed with Secretary Tourism earlier. Also a Memorandum has been submitted on 21.02.2025 to Dr. Arvind Virmani, Hon'ble Member of NITI Aayog on this matter. But TATA Power wants money & that decision has not yet been taken till now by the government & we should wait.

Agenda No. 5 (Managing Staff in small hotels guidelines for NOC)

This is an issue being faced by the industry and all members. In some cities and towns the members have come together and have discussed among themselves to maintain certain decorum in this regard. After deliberations between members present it was concluded that member hotels should not hire staff without proper NOC from previous organization. Members are requested to intimate HRAO regarding their staff leaving their units without notices with their photos CVs for other members' awareness.

Agenda No. 6 (Secretary General's Report)

Sri Milind Gupta, Secretary General read-out about his report for members information. (Report attached)

Agenda No. 6 (Treasurer's Report)

Sri Prasant Kumar Jena, Joint Treasurer was read about the Treasurer's Report for Members information as follows.

Sri Uma Sankar Panigrahy, Vice Chairman briefed that from Icchapuram to Tampararing road needs to be developed by Tourism Department. It is a matter of pride for Odisha that Deomali in Koraput district has become a popular filming location for its stunning natural beauty and diverse landscape attracting major production houses and filmmakers.
