Minutes of the Fire Meeting with DG (Fire) held on 07.05.2025 at OFDRA (Baramunda), Bhubaneswar at 4.00 pm.







Meeting was chaired by Dr. Sudhanshu Sarangi, IPS – DG (Fire) along with Sri Debendra Kumar Swain, Chief Fire Officer (SAG), F.P.W., & they welcomed all members.

He informed that the Cabinet Notification has been done for the proposed changes in the Fire Policy and all Hotels constructed or occupied after 1982 and prior to the commencement of the Odisha Fire Prevention and Fire Safety Rules, 2017 can apply for Fire NOC without having a approved building plan.

The process for application is at present manually and the application has to be made to the Office of the Chief Fire Officer, Bhubaneswar located in Bhubaneswar. Subsequent to the application inspection will be carried out by their team to access reasonable safety measures and on certification from their authorized person NOC for exemption of approved plan will be given. On recipt of NOC online application can be made for getting the Fire NOC of the proposed building.

The Department is holding at Training Program every quarter for operation of Fire fighting and other fire safety measures free of cost. Hoteliers are requested to get their personal trained in operation of Fire Fighting Equipments & avail this oppurtunity. He also informed that as per the directive of Hon'ble Prime Minister, the process of renewal of licences will be done away in due process. The process of training & appointment of Fire Auditors and their Empanelment is being started

and they shall be responsible for giving audit certificate of compliance of Fire Safety measure on basis of which NOC will be extended online.

He also suggested if possible Fire Towers should be created in Staircase area for smooth evacuation in case of any emergency / mishap.

He also informed that the Government intention is to carry out smooth business for the Hoteliers and all cooperation required from the Department in terms of passive dilution of safety measures like set-back, staircase etc., can be considered. But all active measures have to be compiled with.

Members from all over the state interacted and discussed their issues which were addressed to the full satisfaction and we would request all members to take maximum advantage of this opportunity make their buildings fire safety complaint.

We once again request all members who are interest to nominate their personal Fire Safety program, kindly share their name, contact no. with Mr. K.K. Rao for taking it further.

Meeting ended with vote of thanks to the Chair.
